



# Muskingum County Junior Fair Horse Vaccination Entry

## Overview

- 5-way vaccination is required for ALL Junior Fair Horses age yearling and older. Exhibitors must submit documentation of vaccination from a veterinarian **by August 1, 11:59 p.m.**
- If exhibitors have not uploaded their vaccination records to Fair Entry, they will need to log in ([muskingum.fairentry.com](http://muskingum.fairentry.com)) and create an entry under Class 02: Horse Vaccination Record (Due August 1).
- Vaccination records need entered for all registered horses, including back ups.

### Final Steps!

- Review your entries for completeness and accuracy. *Notice the Summary and Detail buttons at the top of the list on the right.* If there are errors, click on the green Entries section at the top of the page. Click “Continue” when all information is correct.
- Once **all entries have been entered for exhibitors in your family for this deadline**, submit the invoice for approval.
- You will receive an email message when the entries have been submitted. If you have not received an e-mail, the process is not complete! **Forward this e-mail to your club/chapter advisor so they know the status of your entry.**
- You will receive a second email when the entries have been approved (after the registration deadline). If errors are found, you may be contacted to correct the error within a reasonable time. Junior Fair participants not meeting the reasonable time deadline will not be permitted to make changes and therefore may be ineligible to exhibit.
