You have the opportunity to participate in one of two different recertification sessions offered this year in Muskingum County. They are:

Tuesday, February 7, 10:00 a.m. –1:00 p.m. at the Rural Services Building, 225 Underwood St., Zanesville. All categories will be covered.

Monday, February 13, 6:00-9:00 p.m. at the Rural Services Building, 225 Underwood St., Zanesville. All categories will be covered.

Pre-registration is expected. There is a \$35.00 fee for the recertification session. Checks should be made payable to OSU Extension- Muskingum County and returned with the enclosed registration form 3 days prior to the session you will be attending. **This fee is in addition to the \$30.00 license fee** of the Ohio Department of Agriculture. Send your \$30.00 renewal fee to O.D.A., 8995 East Main Street, Reynoldsburg, OH 43068 after you have participated in a recertification session. Bring your pesticide card or pesticide license number with you to the meeting.

Fertilizer Applicator Certification Training

Ohio recently enacted legislation creating the Fertilizer Applicator's Certification Training Program. Farmers who are applying commercial fertilizer (not manure) to at least 50 acres or more of field crops such as corn and soybeans will need to be certified. Licensed pesticide applicators will need to participate in a two hour training by September 30, 2017 in order to be certified. Individuals without a pesticide applicator's license will need to participate in an additional hour of training at the session. OSU Extension-Muskingum County will offer two fertilizer certification sessions this winter. They will be held on: **Thursday, March 16, at 10:00 a.m.** and repeated again on **Tuesday, March 28 at 6:00 p.m.** Both sessions will be in the Meeting Room, 225 Underwood Street in Zanesville. Pre-registration is required. Call the office for more information and a registration flier.
